"Youth" is defined by the CDCWMA as any participant 16 years of age or younger on September 29, 2017 and is only eligible for the "Youth" Division. Any participant 17 years of age or older on September 29, 2017 will only be eligible for the Archery, General and Wild Hog Division. Youth may participate in the Wild Hog Division provided they pay an additional \$20.00 Entry Fee.

**Youth** can only enter the **Youth Buck Contest** and **Wild Hog Contest**  
(buck or hog may be harvested by means of Archery)!

**Archery Contest** must be harvested by use of: Compound Bow, Longbow, Crossbow or Recurve Bow

**General Contest** is for muzzleloaders and rifles!

**Wild Hogs** may be taken from October 1 thru January 1 harvest date must be attached with each pair of hog ears no exceptions!
